1) The E-Auction is being held on “AS IS WHERE IS” and “AS IS WHAT IS BASIS” and “WHATSOEVER THERE IS BASIS and NO COMPLAINT BASIS”. To the best of knowledge and information of the Authorized officer, there are no encumbrances on the vehicle, except specifically disclosed herein. However, the intending bidders should make their own independent enquiries regarding the encumbrances, title of vehicle put on auction and claims/rights/dues affecting the vehicle, prior to submitting their bid. The Authorized Officer/Secured Creditor shall not be responsible in any way for any third party claims/rights/dues. The bidders shall satisfy themselves as to the description, condition or accuracy of the details regarding the vehicle given hereinabove.

2) It shall be the responsibility of the bidders to inspect and satisfy themselves about the asset and specification before submitting the bid. Please note that Cheques/Demand Drafts shall not be accepted as EMD amount.

6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.

7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode before **5.00 P.M. on 09.03.2026** shall be eligible for participating in the e-auction. The e-auction of above vehicle would be conducted exactly on the scheduled date & time as mentioned above by way of inter-se bidding amongst the bidders.
